## Invitation to Bid

CY 2018 QUICK RESPONSE FUND (QRF) BATCH 2

1. The *DepED-Division of the City of Ilagan* through the *GAA FY 2018* intends to apply the sum of *Php 3,903,284.18* being the Approved Budget for the Contract (ABC) to payments under the contract for **CY 2018 BASIC EDUCATION FACILITIES FUND QRF BATC 2**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *DepED-Division of the City of Ilagan* now invites bids for **CY 2018 BASIC EDUCATION FACILITIES FUND QRF BATC 2**. Completion of the Works is required *60 CD per lot*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from *DepED-Division of the City of Ilagan* and inspect the Bidding Documents at the address given below from *8:00AM - 5:00PM*.

- 5 A complete set of Bidding Documents may be acquired by interested bidders on *October 15 - November 5, 2018* from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5, 000.00 per lot.*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6 The *DepED-Division of the City of Ilagan* will hold a Pre-Bid Conference on *October 19, 2018 ; 10:00AM* at *Conference Room, Division of the City of Ilagan, San Vicente, City of Ilagan, Isabela*, which shall be open to prospective bidders.

- 7 Bids must be duly received by the BAC Secretariat at the address below on or before *November 5, 2018; 9:30AM*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on *November 5, 2018;10:00AM* *Conference Room, Division of the City of Ilagan, San Vicente, City of Ilagan, Isabela*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8 The *DepED-Division of the City of Ilagan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
